Subject: Permit to photograph – Snæfellsjökull National park

The Environment Agency of Iceland has received an application from Craghoppers LCC, dated 13. June 2019, for photographing within Snæfellsjökull National park.

Snæfellsjökull is protected as a national park cf. Regulation no. 568/2001. A permit from the Environmental Agency of Iceland is needed for any kind of commercial activity.

Description of the project:

Filming will take place on Snæfellsjökull driving up road no. F570 and then on the hiking trail. Outdoor gear for hiking will be photographed. The project will take place at June 24, but the rain date is June 25. The project consists of 10 people, 4x4 Defender and 4x4 Duster. The vehicles will not be taken off roads and the staff will not be entering the central part of the glacier, only the periphery where the snow is and there is snow in the background.

Impact assessment:

The Environment Agency of Iceland considers the project to be minimal and not likely to have negative impact on the environment as long as the rules of the National park and the Nature Conservation Act are followed.

Conclusions and conditions:

The Environment Agency of Iceland hereby grants a permission on its behalf to photograph within Snæfellsjökull, National park, on the 24th and 25th June 2019, as described above, on following conditions:

- Keep this letter with you on site during the project. The permit conditions should be introduced to the staff before the work begins.
- If the dates of the project change the Environment Agency shall be notified as possible.
- The Environment Agency should be informed if there will be any changes to the project description.
- The applicant shall contact rangers in the areas 24 hours before the film crew arrives in the area and inform him on your intentions.
- Off-road driving in Iceland is strictly prohibited.
- Crew members should always stay on authorized paths/tracks/roads.
- It is desirable that the staff will be in marked clothes or vests.
- Fauna, geological formations and landscape should not be disturbed in any way.



- All disturbance to animals and wildlife is strictly prohibited.
- The crew should be conscious of other guests on the sites and make sure that the project causes as little disturbance as possible to other visitors. During early morning and late afternoon, there are less people visiting the sites.
- The project's staff is required to prevent all disturbance to the environment and make sure that all litter is removed from the sites.
- All traces of the work must be removed carefully off the site by the end of the work/project.

If the developer causes damage to the nature, according to Article 87 of the Nature Conservation Act no. 60/2013, the Environment Agency of Iceland can, according to the Nature Conservation Act, f.e. ordered the licensee to fix damage to the nature and vegetation and/or stop the project.


The Environmental Agency of Iceland can amend the conditions, add in new conditions or withdraw the permission, if the environmental conditions change according to Article 89 (2) of the Nature Conservation Act no. 60/2013.

The Environmental Agency of Iceland can withdraw the permission if the terms of the conditions are not met according to Article 89 (1) of the Nature Conservation Act no. 60/2013.

Permission fee:

Environment Agency of Iceland charges a fee for processing applications for permits in protected areas based on Article 92 of Act no. 61/2013 on Nature Conservation. The fee for photography is 52.600 ISK according to art. 24. b. in the agency's tariff no. 535/2015.
